## 110 18/19 Introduction and Welcome Governors introduced themselves and welcomed JHF to our Governing Body. #### 114 18/19 Governing Body Membership

This is HS's last meeting. She has promised to stay in touch and will continue to visit school regularly. Governors will sincerely miss her knowledge, reliability, experience, enthusiasm and kindness.

Following HS's departure, there will be three Governor vacancies again with 1 for a foundation Governor and 2 for foundation trustee Governors. JS is aware of the possibility of 1 or 2 possible volunteers and will chase with the trustees.

Committee membership and special roles were discussed ensuring that JHF is included and HS's departure is covered.

#### 115 18/19 **Declaration of Business Interests**

# 116 18/19 **Minutes of previous meeting** The minutes of the meeting held on 1<sup>st</sup> April had been previously distributed. A slight correction to the minutes was requested, with it being noted under minute number 090 18/19 that JH started on Tuesday 14<sup>th</sup> May, and not Monday as typed. Other than this the minutes were agreed as correct and signed by JS.

#### 119 18/19 **Committees:**

#### Curriculum Committee – Chair HS

Minutes previously distributed, read through by JH. The following salient points were discussed in more detail:

JH spoke about the new class structure from September, separating the students into four groups (Rec, yr 1&2, yr 3&4, yr 5&6). Governors unanimously approved of the new structure.

JH talked through the purchase and location of the new IT suite, which Governors had previously been emailed about. Governors discussed thoroughly all aspects of this, and unanimously agreed on the purchase and location.

JH spoke about the ring-fenced sports funding and the entire sports provision currently offered at Taddington. From September the school will change the provisions to ensure that sports are provided in a holistic, challenging, interesting and innovative way throughout the year. Working with the Whitehall centre, all students will be offered a variety of on and off-site activities. Katie Furniss will also be teaching Forest School to all students in our on-sit woodland. This may be offered to other local schools at a minimal cost.

JS spoke about the impact of the above initiatives on school finances, personnel, buildings etc. Governors unanimously agreed that there are no areas of immediate concern, but the changes will be monitored and feedback brought to Governors. Governors appreciate JH's enthusiasm and significant time and thought given to improving the education and well-being of our students.

#### Finance Committee – Chair JS

JS spoke about finances in general and specifically in relation to the above changes. JS asked for Governor approval to fund training for Caroline Parsons in accountancy, which will directly benefit her current position as SBM. Governors unanimously agreed.

The committee had met but minutes were not yet written to present to Governors.

## Personnel Committee – Chair JS

Not met.

Buildings and H&S Committee – Chair JS Not met.

### 120 18/19 Headteacher's Report

JH read through the report which had been previously distributed.

#### HW left the room.

JH talked about the requirement for a trained SENCO, and asked for Governor approval to appoint HW who has extensive experience and all necessary (and many additional) qualifications. Governors unanimously agreed. HW will also be able to offer some early help provision, which has been cut by DCC. JH and JS to formalise.

#### 121 18/19 **Resources**

JH explained the maths and English resources (some new and some existing) that will be used to support teaching. The school are trialling the use of 'Power Maths' which is an accredited scheme to teaching maths with a problem-solving, real-life focus.

## 123 18/19 **Proposed improvements to the learning environment**

JH talked through the replacement of the conservatory roof with a solid and insulated version, due for work to be completed over the summer.

#### 124 18/19 Summer 2 Summative data

JH talked through the data, explaining that it is based on an extremely small cohort of 3 children, which limits to ability to make general judgements. The results were discussed in depth by governors, who noted and agreed with the importance of progress rather than attainment.

JHF left the meeting at 9:20pm

#### 125 18/19 Outcomes of the LA advisor scrutiny

JH talked briefly about the report from Steve Ford, which most Governors had previously received. The findings were positive with no notable causes for concern.

#### 126 18/19 REHO (Early Help Offer)

HW in new position of SENCO will look into this further, working with JH from September to ensure that adequate (if not excellent) provision is in place.

127 18/19 Sports Funding and Pupil Premium Sports Funding Discussed under Headteacher's report.

#### **Pupil Premium**

JH is currently assessing how value-added is measured and will report back to Governors in September.

#### 128 18/19 **Policies**

Of the policies for agreement, one had been recently reviewed, one is not required at the moment, and the other two will be brought to the September meeting.

JH is writing a new plan for academic year 19/20, to be brought to Governors in September.

#### 131 18/19 Extended Services / Explorers

CP talked through the ongoing financial position of the afterschool club. Numbers are low resulting in a worrying financial position. Governors appreciate the symbiotic benefit of having this provision to NOR and appeal for new families, and will monitor closely.
